## TERMS AND CONDITIONS

WishWin is a 501c3 certified, 100% volunteer-driven non-profit organization that organizes academic contests in order to ensure that students enjoy and benefit from the experience. The WishWin contests are meant to promote academic excellence and recognize students for their talent and hard work.

**The terms and conditions below are applicable for all contests and forums.**

1. All registrations should be submitted online. It is the responsibility of the parents to register their children by providing the correct information as needed.
2. Every contest has FAQs provided on the WishWin website. It is recommended that parents read the FAQs and understand them before registering the students.
3. By registering a child in WishWin Contests, parents acknowledge and authorize permission for the student name, video, digital or still photography made with the child's image to be applied to a variety of uses by WishWin. Such uses may include but are not limited to, WishWin's website, printed brochures, and/or other forms of electronic transmission.
4. It is the responsibility of the contestant to be present at the location specified as per the schedule circulated prior to the contest.
5. The organizers retain the right to start the contest as per the schedule provided. There may occasionally be delays to contests based on logistics or to allow for all contestants to be checked-in.
6. Once registered, there will no refunds or carry forward of funds if the participant fails to attend a contest.
7. Except during the tests/exams where parents are not allowed, it is the responsibility of the parents to take care of their children and keep them under their care at all times. Parents are requested to wait outside the exam room and pick up their children as soon as he/she finishes the exam.
8. Contestants are responsible to bring the required items such as pens, pencils, and erasers. The exam/test packets will be provided by the organizers.
9. The winner of a contest will be declared as the contest champion.
10. Parental interruption of any form during the competitions is not acceptable and based on the discretion of the organizers, the contestant may face disqualification.
11. The organizers retain the right to change the logistics, venues, dates, rules, regulations, fees and mode of conducting the contest at any time.

12. Any changes to the rules will be announced before the start of the competition; the judges always have the right to change rules on site without prior notice if the situation warrants. All decisions by the judges are final.
13. Photography, videography and any use of cameras is strictly prohibited during the contests by students, parents and observers.
14. Parents are not permitted to copy questions, answers, or words during a contest.
15. WishWin organizes the contests and forums for the benefit of students. The organization, the officers, sponsors, and volunteers will not be responsible for any human error and consequent hardship, in any form, caused to any person(s) or organization(s).
16. The WishWin, officers, volunteers, and sponsors will not be held responsible for any act, outcome, or consequence resulting from any aspect of any student's or parent's participation in any of our contests.
17. In case a contest does not take place on the designated date under circumstances beyond the control of the organization, the organizers will try to reschedule the contest to a later date.
18. The organizers reserve the right to change, modify or otherwise alter these rules and conditions at any time.
19. During Spellathon, parents cannot help students as they try to spell the words. In case any such occurrence happens, the parents will be asked to leave the room and the contestant will face disqualification.
20. During Spellathon, a contestant can appeal and request for a review of the judge's decision before the start of the next round. Parents are not allowed to approach judges directly. Parents can submit a written appeal to a volunteer who will then refer the matter to the judges at the end of that round. In any appeal, the decision of the judges is final.
